

RULES AND REGULATIONS OF POL'AND'ROCK FESTIVAL 2019 FESTIVAL GROUNDS.

31.07-4.08 2019, KOSTRZYN NAD ODRĄ, POLAND.

1. Pol'and'Rock Festival is a free admission public event, held in an area open to the public. The festival is a non-ticketed event.
2. Mass gatherings and other events, held during the festival, are regulated by a separate set of Rules and Regulations.
3. Due to increased security measures in force at the festival, each member of the audience must submit to body search and/or luggage inspection.
4. Persons who refuse to submit to body search and/or luggage inspection will be refused entry into the mass events.
5. Tents can be located only in the areas designated by the promotor of the festival.
6. At the grounds of the Pol'and'Rock Festival 2019 it is strictly forbidden to:
 - A. bring alcohol, drugs, designer drugs, other psychoactive substances and drugs;
 - B. sell alcohol, drugs, designer drugs, other psychoactive substances and drugs; display aggressive and/or violent behaviour
 - C. bring any glass containers, items which might be hazardous to human health or otherwise pose any danger to human life;
 - D. use open fire such as campfires, gas cylinders;
 - E. bring and store any pyrotechnic devices and flammable substances
 - F. smoke in woodland surrounding the festival site;
 - G. climb onto the festival stages, festival infrastructure and constructions
 - H. drive motor vehicles on the festival grounds;
 - I. Park any motor vehicles on evacuation and fire escape routes or any other traffic routes. Failure to comply will result in vehicle being towed away. Cars and other motor vehicles can be parked only in the areas appointed by the promotor
 - J. operate remote-controlled unmanned aerial vehicles (drones)
7. It is forbidden to consume alcohol, especially in the areas marked as alcohol-free zones (PL: strefa wolna of %).

8. Sale and consumption of beer must be restricted to designated areas.
9. It is forbidden to hold any other events, such as exhibitions, trade activities without express written permission from the promotor of the festival.
10. It is forbidden to undertake any marketing, advertising, or publicity activities at the festival and camping grounds without the promotor's express written permission.
11. Please note: mass gatherings and events as well as the festival grounds will be recorded throughout various outlets of the promotor and promotor's partners. All audience members and persons present at the mass events and at the festival grounds agree to the possibility of appearing on the recordings and by virtue of attending the event grant permission for their image to be used, published and distributed (both commercially and non-commercially), free of charge and using all kinds of media (both physical and digital: including, but not limited to digital, optical, and data transmission).
12. It is forbidden to record (audio, video, audio-visual) and photograph (digital, analogue photography) concerts, meetings, theatre plays and other performances taking place during the mass events for the purpose of public dissemination, using any technique or medium, including, but not limited to websites such as www.youtube.com; www.facebook.com; www.twitter.com and other websites and online applications without prior permission issued by the promotor of the festival.
13. In order to ensure the participants' safety, the promotor of the festival introduced video surveillance, which will be in operation on the site of mass gatherings. Your data, obtained through the video surveillance system, will be controlled by the Great Orchestra of Christmas Charity Foundation (Dominikańska 19c, 02-738, Warsaw). More information about festival privacy policy is available online.
14. Destroying property located at the festival grounds shall be punished in keeping with general applicable laws.
15. Violation of any provision listed in these Rules & Regulations will result in an order to leave the festival immediately.

The promotor of the festival appeals to members of the audience to keep the area of the festival clean and tidy. Please dispose of all the rubbish after leaving your campsite!

* These Rules and Regulations will be made public, published on information boards located on the festival site and in festival-related print publications. Rules and Regulations will be available online, published on the promotor's websites. Anyone entering the festival grounds agrees to comply with these Rules and Regulations.
